1. Priority in location of leased space shall be given to vendors in the **order that they return signed contracts with payment.**
2. Vendors must abide by show and Health Department rules designed to protect the health of the public, as well as, vendors and their staff. Regulations are also in force by the City of St Petersburg's Fire & Rescue Department regulations particularly with regard to cooking.
3. All items for sale must be conspicuously priced on signs for the food items and on signs near the individual items of merchandise.
4. Every food vendor shall have a fire extinguisher designed for electrical fires and if the booth is preparing or heating food it must also have a fire extinguisher designed for grease fires. You must provide all proper extinguishers.
5. Vendor shall submit with this contract proof of Certificate of Liability insurance coverage effective for Saturday, September 11, 2010 submitted prior to August 23, 2010 naming 22<sup>nd</sup> Street RDC & St. Petersburg Clay Company as additional insured.
